SCOPE OF SECURITY MANAGEMENT SYSTEM

Our Security Management System covers the provision of contracted logistic security services. The service includes accommodation, provision of MSOs to our PMSC clients, safe storage and handling of firearms, and transfers to/from PMSC's clients in their transit across high threat areas in the Red Sea, Gulf of Aden, Indian Ocean and Arabian Sea.

SECURITY MANAGEMENT OBJECTIVES

Palm Charters provides a secure working environment by establishing and maintaining security measures to help prevent situations on board our vessels which endanger the safety and security of our clients and workers.

In order to achieve our mission statement, we have set clear security objectives to guide us throughout our activity:
